Discussion Starter

- What is one thing about yourself that might surprise people to know?
- For those people that you know well, what do you think would be one of the first things they would say about you when describing you?

Opening Prayer

Ask if someone wants to volunteer before leading the prayer.

Breaking it Down

- All questions should be utilized as appropriate based upon group dynamics to facilitate both understanding and discussion. Don't feel tied to the questions and don't feel like you must get through every question. Follow the Spirit's lead! All questions are a matter of perspective in some way BUT there are specific questions that this is truer of, and these questions have been indicated to be perspective/opinion questions.
- Please use your own style, voice, and approach in preparing for leading your life group. Most importantly, take a few minutes to pray over the time together with you group and pray over each group member by name.

Tell the Story

• PLEASE MAKE SURE THAT YOU HAVE ONE PERSON WHO STORIES (SUMMARIZES THE CHAPTER) BEFORE THE GROUP READS THE CHAPTER TOGETHER.

Read the Story (James 2:1-26)

Read out loud as a group, 3-5 verses per person. Let everyone know they can opt out if they would like.

James 2:1-13

 - o In what ways do you view and see people through your own biased and prejudiced lenses rather than through the eyes of faith and Jesus Christ? What can you do to more fully and intentionally see all people through the eyes of faith and Jesus Christ?
 - These are perspective and opinion questions so please listen as the facilitator.
- ☐ What is James' argument against favoritism and partiality in verses 5-7 and why is this important for us to remember as followers of Jesus?
 - o James' argument is that those who are considered to be "less than" are frequently those individuals who have a deep amount of faith in God, ones that followers of Jesus might possibly need to be imitating and following. His argument is also rooted in the reality that those to whom partiality is being shown are frequently the ones who are not rich in faith.
 - What is convicting and sobering about the above realities as a Jesus follower?
 - This is a perspective and opinion question so please listen as the facilitator.
