2s & 3s Registration Information 2026-2027

Enrollment of our current River students, their siblings, and siblings of past students will begin on January 6th, 2026 for the 2026-2027 school year. Registration for River Christian Church members and registered members of the RCC MOMs group will begin on January 20th. Registration will open to the public on January 26th. **Please remember that all openings are on a first-come, first-served basis depending upon availability at the time of registration.** For our students in the 2s and 3s programs, we offer a 2-day a week class on Tuesdays and Thursdays, and a 3-day a week class on Mondays, Wednesdays, and Fridays. Children who attend the 5-day program will be part of a MWF class and a T/TH class unless we have enough students enrolled for a Monday-Friday class. **It is a requirement that ALL students in the 3s program are fully potty trained and able to use the restroom independently.**

Enrollment

To secure a spot and enroll your child for the 2026-2027 school year, the following must be completed **at the time of registration and submitted in person:**

1. Enrollment Form - be sure to record at the top of the form your program choice (MWF, T/TH, or 5 day).
2. Registration Fee in the amount of \$250.00.
3. Birth Certificate to verify age.

****All registration fees are non-refundable and are required to secure a spot****

Admission

In our 3-year-old classes, it is our policy that each child must be fully potty trained (not in pull-ups).

The following must be completed and submitted in person:

- Enrollment Form (at time of registration).
- Registration Fee (at time of registration).
- Birth Certificate to verify age (at time of registration).
- HRS health forms furnished by your physician:
 1. Immunization/Religious Exemption Form (must be received before August 25th, 2026).
 2. Most recent Physical (must be received before August 25th, 2026).

Tuition

Tuition is due on the first of each month and is late after the 5th. A \$10.00 late fee is charged for payments received after the 5th.

It is important to remember our tuition is based on a daily price and the preschool runs on a 150-day calendar. Clay County runs on a 180-day calendar; we will always be closed on Clay County elementary half days, as well as additional closed days throughout the school year. Please review the attached calendar of holidays and closures for the 2026-27 school year.

Orientation and First Day Info

Orientation will be held Tuesday, August 25th. At Orientation, the students will visit their class and meet their teacher. You will receive a postcard during the first week of August, giving you specific information regarding teacher assignments and times for Orientation. The first day for the 5-day program and MWF classes will be Wednesday, August 26th and the first day for the T/TH classes will be Thursday, August 27th.

Hours and Extended Hours

Our primary hours of care are 8:50AM until 12:20PM for the 2- and 3-year-old classes. Our carline begins at 8:50AM and ends at 9:00AM for arrival. At dismissal, our carline begins at 12:20PM and ends at 12:30PM. There are late fees applied for children who are not picked up by the end of carline, please see the student handbook for more details.

****Students must be on time every day, as it is a disruption to arrive late during class time. Any tardiness after 10:30AM will not be permitted unless you have a doctor's note.**

We do offer an extended program.

- Early Morning Drop-Off is available from 8:30AM-9:00AM for \$5. Children will not be accepted for early drop-off before 8:30AM. Students are walked into the preschool and signed in at the preschool desk. Payment for Early Drop-Off is due each day or added to monthly tuition payment. No prior notice is needed.
- Extended care is available from 12:20PM until 2:00PM Monday through Friday. Our carline will run from 2:00PM until 2:10PM (at the VPK side entrance) for extended care dismissal. **Students must be fully potty trained to stay for extended days (not in pull-ups).**
- The fee for extended care is \$15 regardless of how long the child stays. The fee should be sent in on the morning your child plans to stay or added to your monthly tuition payment. **The parent(s) must notify the teacher or admin that their child is staying for extended no later than 10AM the day of.**
- It is the responsibility of the parent(s) to provide a lunch separate from their snack.

Discipline

In compliance with HRS Section 10M-12.013, we will never use physical punishment as a means of discipline. In the area of discipline, we make it our priority to teach through consistency and loving guidance.
